This survey is tailored towards students as well as staff. For students the survey asks if they have Supportive Relationships, Teacher-student relationships, Sense of belonging, School Climate, Engagement, and Cultural Awareness and Action. For the Teachers the survey asks if they have Staff-Leader Relationships, School Climate, Belonging, Well-being, Cultural Awareness and Action and Teacher Self-Reflection (Teachers only).</p> <p><b><i>Community Events Committee</i></b></p> <p>Bridget reported to the coalition that today is our Mardi Gras In the Zone event. Our trailer is already set up at the Pennington Center site along with the light tower. Bridget thanked Matthew Foster and SELU Health Center for helping the coalition in sponsoring this. We currently have 38 families signed up with 156 total individuals coming.</p> <p>Jason reported that the committee decided to only have the educational square at the Strawberry Festival on only that Friday from 12PM-6PM. We are only asking for volunteers for 2-hour blocks if needed. We want to have all activities there and ask that if partners would like to give literature from their organization to give out. Michael Otkins made a motion to only participate in the Strawberry Festival Educational Square the one day. Matthew Foster seconded that motion. Motion carries.</p> <p><b><i>Media Committee</i></b></p> <p>Bridget reported to the coalition that we have received the quote from the Gagliano Group. There were some questions about some items on the quote, and those were addressed. The cost of new media will be around \$56,000 and includes this month through December. This includes all deliverables, new content, social media, and geocaching in our area. Michelle Gallo made a motion to accept the contract with Gagliano Group and Strader Cieutat seconded the motion.</p> <p>Bridget reported that we will also need to renew our contract with Northshore Media for our radio interviews, radio ads, and for a spot in the Tangi Lifestyles magazine. Matthew Foster made a motion to renew the contract with Northshore Media and Michelle Gallo seconded the motion.</p> <p><b><i>Youth Committee</i></b></p> <p>The Youth Committee meeting will be on March 12th at 2:00PM.</p> <p>Taylor updated the coalition on the schools that have currently registered for the forum. TRACC staff will be reaching back out again.</p> <p>Cali reported to the coalition that we will have 8 sections of the maze portion, and we have all the volunteers for the sections. However, we do need more volunteers to usher through the maze.</p> <p>Gaylin reported that TRACC staff have reached out to our business partners that participated in our Red Ribbon Week to see if they would be willing to donate. TRACC staff has asked if anyone in the coalition would like to help get door prizes to please let us know.</p> <p><b><i>Sustainability Committee</i></b></p> <p>Bridget reported that in the last committee meeting we discussed issues that we felt we had with our By-laws. Since the By-laws does define the difference between a member and a partner, no changes were made.</p> <p>Taylor reported that she attended a sustainability webinar, and they gave an example of a sustainability survey that the coalition can take part in to give feedback on how the coalition is doing. Taylor will be sending that out.</p> <p>Bridget reported that the committee and TRACC staff are looking at our action plans and gathering data to see if any changes should be made.</p>
