Welcome/ Introduction	<i>Introductions</i>	The meeting was called to order at 12:07 PM by Paula Zachary who also welcomed everyone to the TRACC meeting. The meeting was held at the Clausen Building in Hammond, LA. All in attendance, in unison, read the TRACC mission statement which is located at the top of the agenda.

Michelle Gallo stated that the Hammond Rotary is generously donating an extra \$215.00 to make a total of \$500.00 to contribute to the KEYS Alliance "Stomp Out Tobacco" fundraiser, in hopes to continue to build this partnership in years to come.</p> <p>Bridget Bailey reported that Tangipahoa Parish Government Administration gave approval to purchase a utility trailer to haul and store our supplies for events. The trailer has our prevention logo and is ready to be used by the coalition for events.</p> <p>Taylor reported that there will be a Make the Case Training for Law Enforcement on May 31st here at the Clausen building. Aaron was successful in lining up an instructor from BRPD as well as having our own Assistant District Attorney's from the 21st JDC, LeAnne Malnar and Matt Belsar. Aaron reported that the new instructor Jason from BRPD is highly motivated and a passionate instructor. This training is provided through our LHSC grant.</p> <p>Taylor reported that TRACC will be participating in the End of School Bash, hosted by Crimestoppers. The event is being held at the Hammond Rec Center from 4pm-6pm. Michelle reported that the location changed due to the weather; however we are hoping to have a good turnout.</p> <p>Bridget reported that according to our action plans we are to hold a Town Hall or Legislative Forum. We try each year to alternate having one of these events. Last year we held a Legislative Forum so this year we would like to hold a Town Hall. We need to schedule a meeting and begin planning the Town Hall event. This event is typically held at the end of July or in August/September before our State legislatures go back into session. The Community Events committee needs to set a date to discuss and review topics that we would like to address with our state and local elected officials.</p> <p>The next radio interviews will be on May 31st, and June 13th. We invite all Coalition members who would like to attend to please let us know.</p> <p>Bridget reported that we had a media committee meeting this past week and the committee decided to go with two radio pieces that the students created. Those ads are now playing on the radio.</p> <p>Taylor reported that in our last TRACC Meeting the youth committee brought to the coalition that they thought it was a good idea to bring KEYS to the schools. The coalition voted to move KEYS to the schools, having us go to them instead of them coming to us. There has been interest in KEYS expressed at Kentwood High and possibly Hammond High School. The Youth committee would like to come up with a toolkit to help the sponsor with the meetings and objectives that should be followed. We will be meeting to get this toolkit together.</p> <p>Taylor reported that some summer opportunities for our current KEYS members are CADCA Mid-Year and the local PA camp. We currently have 3 JR High active members and 1 High School active member. The Youth committee decided that the PA camp was the best option for our current KEYS kids. Letters have been sent out to the parents and we hope that we have some interest. Those letters are due back by May 29th.</p> <p>Bridget reported that at our Legislative Forum last year we discussed the issue of Kratom. She explained that there are no regulations on Kratom from a Federal standpoint at this time, however local governing authorities are starting to ban the sale of this item. With this being said our kids have easy access to this item in our gas stations. Bridget asked all members of the Coalition to attend our Parish Council meeting on May 28th to support this issue.</p> <p>Nanette Bester from Southeast Community Health System presented that they are starting up a Youth Mobile Unit for youth ages 20 and under that are going through a crisis. They will go to the child wherever they are. This is a 24/7 available unit and is not limited to one child at a time. This unit will follow the child for 72 hours and will either admit or work to make the necessary referrals for the child in need. The crisis unit would like to take care of every juvenile as long as the situation is not one of danger.
